HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30TH NOVEMBER, 2013

1. The total number of companies registered in the country as on 30th November, 2013, stood at 13,59,120. Of them, 2,66,564 companies were closed; 1,43,575 companies were lying dormant; 5,012 companies were under liquidation; 24,360 companies were in the process of being struck-off and 266 companies were in the process of being re-activated after earlier being dormant. Taking the above into account, there were 9,21,642 active companies (companies at work) as on 30th November, 2013. **Table-1.1** presents the summary picture of companies as on 30th November, 2013.


2. The total number of closed companies as on 30th November, 2013 stood at 2,66,564. Of them 10,187 companies were liquidated/dissolved; 2,41,742 companies were defunct and hence struck-off; 13,275 companies were amalgamated/merged with other companies; 1,360 companies are converted to LLP. **Table-1.2** presents a summary of closed companies as on 30th November, 2013.

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,77,437), followed by Delhi (2,53,760) and West Bengal (1,78,338). **Table-1.3** presents State/UT-wise distribution of registered companies as on 30th November, 2013. Maharashtra, Delhi and West Bengal together account for more than 50% of companies in the country. Amongst 'Active Companies', Delhi has the maximum number of active companies (1,84,178), followed by Maharashtra (1,83,668) and West Bengal (1,30,216).

4. About 32% of the active companies have authorized capital of less than or equal to Rs. 1 Lakh each; about 52% active companies have authorised capital less than or equal Rs. 5 Lakh each; 64.5% of companies have authorised capital less than or equal to Rs. 10 lakh each; and about 88.6% of the active companies have authorized capital less than or equal to Rs. 1 Crore

each. Only about 2.1% (19,567 in number) of companies have authorized capital of above Rs.10 crore each. (Table-1.4 and Figure 1)




II. REGISTRATION OF NEW COMPANIES DURING NOVEMBER, 2013

5. During the month of November, 2013 a total of 7,335 companies were registered with authorized capital of Rs. 3,025.82 crore. Of them 7,303 Companies were registered as Companies Limited by Shares with an authorized capital of Rs. 3025.76 crore; 31 Companies Limited by Guarantees with authorised capital of Rs. 5 lakh; and 1 Unlimited Liability Company with authorised capital of Rs. 1 lakh **(Table-2.1)**.

6. During November, 2013 Delhi has 1,597 (21.8%) newly registered companies, followed by Maharashtra with 1,158 (15.8%), and Andhra Pradesh with 620 (8.5%) companies registered during the month **(Table-2.2)**.


7. Economic-activity wise classification of newly registered companies during November, 2013 (**Table-2.3 and Figure 2**) reveals that the predominant share of companies are in Business Services (34.9%) followed by manufacturing (15.3%) and construction (10.3%). Business Services comprise

IT (Information Technology), Research & Development and other business activities (law, audit & accounts and consultancy, etc.)




Note: 'others' category includes Agriculture and Allied Activities, finance, insurances, Electricity, Gas & Water companies, Transport, storage and Communications and quarrying and mining.

8. The Service Sector account for 69.4% of companies registered in November, 2013, followed by Industry and Agriculture accounting for 28% and 2.5% respectively (**Figure 3**).



9. Within the Service Sector, 50% of newly registered companies were in Business Services; 15% in real estate and renting; 14% in trading and 13% into community, personal, and social services (**Figure 4**).



10. Newly registered companies in November, 2013 have an authorized capital of Rs. 3,025 crore. Of them, three Government Companies (**Table 2.4**) account for an authorized capital of Rs. 2,060 crore. Lucknow Metro Rail Corporation Limited alone has an authorized capital of Rs. 2000 crore followed by Jharkhand Urban Infrastructure Development Company Limited with an authorized capital of Rs. 50 crore and Odisha State Medical Corporation Limited with an authorized capital of Rs. 10 crore.

11. Number of LLPs (Limited Liability Partnerships) registered during November, 2013 was 493 with Obligation of Contribution of Rs. 115 Crore. Highest number of LLPs were registered in Maharashtra (32%) followed by Karnataka (16%) **(Table 2.5)**.

12. Economic activity wise classification of newly registered LLPs during the month of November, 2013 (**Table-2.6**) reveals that predominant share belonged to Business Services (41%) followed by construction (12%), and real estate and renting (12%).

13. Sixteen foreign companies were registered during November, 2013 with place of business at different states of India with maximum of 6 companies in Tamil Nadu (**Table-2.7**). Highest number of foreign companies (10 in number) were registered under Business Services category (**Table-2.8**).
